## Your Donation

When making your donation, you may choose to contribute to a general tax credit category, specific activity or program of the public school that supplements a school's educational program. A.R.S. §43-1089.01, defines extracurricular activities for which tax credits may be used as:

School sponsored activities that require enrolled students to pay a fee in order to participate, including (but not limited to) fees for band uniforms, equipment or uniforms for varsity athletic activities, scientific laboratory materials, in-state or out-of-state trips that are solely for competitive events. Extracurricular activities do not include any senior trips or events that are recreational, amusement, or tourist activities.

## Arizona Tax Law

### (A.R.S. § 43-1089.01)

Arizona Tax Law allows all Arizona residents, with or without children, to contribute up to \$200 per person, \$400 maximum for a married couple. Extracurricular programs such as sports are not funded and depend on fees from students.

You may donate less than \$200 and you will receive the state tax credit in the exact amount you donate. For example, if you donate \$50, your Arizona state tax bill would be exactly \$50 less than you would otherwise owe. If you write a check for \$50, you might even receive a check back from the State of Arizona. In addition, the benefit carries over to your federal return with an average federal savings of one-third of your donation!

If you would like to contribute, complete the form on this brochure and return it to the school of choice. You will be mailed a receipt for the amount of your deduction.
